

# **Dollar Tree's Monster Manor Halloween Game Sweepstakes Official Rules**

## **CONTEST DATES**

The Dollar Tree's Monster Manor Halloween Game Sweepstakes (the "Promotion") is being held by Dollar Tree Stores, Inc. ("Dollar Tree"). The Sweepstakes Entry Period (the "Sweepstakes Period") begins at 12:01am Eastern Time ("ET") on Sunday, September 1, 2013 and closes at 11:59pm Eastern Time ("ET") on Thursday, October 31, 2013 (the "Promotion Period"). Entries received after Thursday, October 31, 2013 at 11:59pm Eastern Time ("ET") will be disqualified. The Sweepstakes Period consists of three (3) phases as set forth below:

Phase 1: Submission: September 1, 2013 – October 31, 2013

Phase 2: Judging: November 1, 2013 – November 30, 2013

Phase 3: Winners Announcement: December 1, 2013 – December 31, 2013

For the purpose of this Promotion, each phase will begin at 12:01am Eastern Time ("ET") and will end at 11:59pm Eastern Time ("ET"). Sway® is the official time-keeping device for the Promotion.

## **PROMOTIONAL ELIGIBILITY**

No purchase is necessary to enter or win. This offer is void wherever prohibited or restricted. All applicable federal, state and local laws and regulations apply. The Promotion is open to legal residents of the contiguous forty-eight (48) United States and the District of Columbia who are age eighteen years old (18) or older as of October 31, 2013. Upon successful completion of the entire Halloween Game, the Entrant will supply their email address to earn one entry for the Dollar Tree's Monster Manor Halloween Game prize. Upon successful completion each Bonus Game, the Entrant will supply their email address to earn one entry for the Bonus Game prize. Multiple entries are permitted.

## **WINNER SELECTION**

Entrants may win up to one (1) Bonus Game and/or one (1) Halloween Game prize.

During Phase 2: Judging, the potential winner(s) will be selected from eligible entries received during Phase 1: Submission using a Random Number Generator (RNG). The odds of being selected as a potential winner depend on the number of eligible entries received during the Phase 1: Submission period. Potential winners will be notified via email address supplied during the Promotion entry and will be asked to provide their full name, age and mailing address within (a specified time period). Winners will be announced during Phase 3: Winners Announcement. Prizes will be mailed within four weeks of Phase 3: Winners Announcement.
